# MULTIPLE SUBJECT/SINGLE SUBJECT PRECONDITIONS

## **Precondition 1**

Limitation on program length. The professional preparation coursework that all candidates are required to complete shall be equivalent to no more than two years of full-time study at the institution. The limitation applies to postgraduate teacher preparation program. The limitation does not apply to blended/integrated programs of subject matter preparation and professional preparation teaching internship programs. Reference: Education Code Section 44259(a) and (b)(3)

Clarification of Program Precondition 1: Individually Prescribed Courses. Program Precondition 1 does not apply to additional courses that are required if a candidate is unable to meet the Commission's standards of candidate competence and performance by completing the regular professional preparation program.

### Response

The traditional multiple and single subject can be completed within two semesters of full-time study. The program requires completion of pre-requisite courses during the undergraduate program of study, methods courses in the first semester following completion of the bachelors degree, and student teaching in the second semester.

## **Precondition 2**

Limitation on Student Teaching Prerequisites - No college or university shall require candidates to complete more than the equivalent of nine semester units of professional preparation courses (as defined in Program Precondition 1) prior to allowing candidates to enroll in student teaching in elementary or secondary schools. This restriction may be increased to the equivalent of twelve semester units if the student teaching prerequisites include study of effective methods of English language development as required by Program Precondition 3.

### Response

Students complete 38 hours of fieldwork prior to beginning their student teaching. Fieldwork is required in the following classes: EN316, ED 503, ED 506, ED 501A,

### **Precondition 4**

Undergraduate students of any campus of the California State University or the University of California shall be allowed to enroll in any professional preparation course.

### Response

The San Diego Christian College Department of Education is in compliance with allowing any California State University or University of California undergraduate student to be enrolled in our credential program.

### **Precondition 5**

Assessing Candidates for Subject Matter Competence – The program sponsor has a timely and systematic process for evaluating and notifying candidates of their standing in relation to the subject matter competence requirement. This process includes:

- Providing candidates with clear and accurate information in all advising and application materials about all options available to demonstrate subject matter competence, pursuant to Education Code Section 44259(b)(5)(a).
- Within the first 60 days if the candidate's admission, the institution must complete and assessment of each candidate's standing in relation to demonstration of the subject matter competence requirement, including whether a coursework evaluation will be needed, and notify the candidate of that standing.

## **Response**

Candidates are provided with information concerning all tests when applying for admission to the TCP Program. The admissions page of our website provides information about the tests.

Students will be notified withing 60 days of admission to the program, advising whether or not they are exempt from CBEST/CSET testing.

## **Precondition 6**

Demonstration of Subject Matter Competence – The approved preliminary teacher preparation program sponsor determines that each candidate meets the subject matter requirement prior to being given daily whole class instructional responsibilities in a TK-12 school.

- A) For Multiple Subject and Single Subject programs, the candidate provides evidence of having demonstrated subject matter competence through one of the following methods:
  - 1. Completion of a subject matter program approved by the Commission on the basis of standards of program quality and effectiveness. Reference: Education Code 44259 (b)(5)(A)(i).
  - 2. Passage of a Commission-approved subject matter examination. Reference: Education Code 44259 (b)(5)(A)(ii).
  - 3. Successful completion of coursework at one or more regionally accredited institution of higher education that addresses each of the domains of the subject matter requirements adopted by the Commission in the content area of the credential pursuant to Section 44282, as verified by a Commission-approved program of professional preparation. Coursework completed at a community or junior college that is regionally accredited by an accrediting agency listed in subparagraph (A) of paragraph (1) of subdivision (g) of Section 44203 or by the Accrediting Commission for Community and Junior Colleges of Western Association of Schools and Colleges may count for purposes of this clause. Reference: Education Code 44259 (b)(5)(A)(iii).
  - 4. Successful completion of a baccalaureate or higher degree from a regionally accredited institution of higher education with the following, as applicable.
    - For Single Subject credentials, a major in one of the subject areas in which the Commission credentials candidates, as indicated in Education Code 44259(b)(5)(A)(iv)(I) and 44282 (b).
    - For Multiple Subject credentials, a liberal studies major or other degree that includes coursework in the content areas as indicated in Education Code 44259(b)(5)(A)(iv)(II) and 44282 (b).
    - A combination of the methods described in 1, 2, or 3 above that together demonstrate that the candidate has met or exceeded the domains of the subject matter requirements adopted by the Commission. Education Code 44259 (b)(5)(A)(v), and 44282 (b).
    - For integrated undergraduate programs only: the candidate must be monitored by
      the program for subject matter competence prior to beginning early field
      experiences and throughout the program until such time as it has been determined
      that the candidate has satisfied subject matter competence. Each candidate in an
      integrated undergraduate program must have satisfied subject matter competence,
      or at a minimum completed four-fifths of the Commission-approved subject
      matter preparation program, prior to beginning daily whole class instruction

### Response

Students enrolled in the undergraduate Liberal Studies program are required to take the CBEST/CSET while enrolled in various courses, unless the student will be exempt from the CBEST. Students seeking a Multiple Subject Credential take the RICA after completion of ED 501A/ED 501B. All students are required to submit evidence of meeting the CBEST/CSET/RICA requirement when applying for Student Teaching.

# **Precondition 7**

Completion of Requirements – A college or university or school district that operates a program for the Preliminary Multiple or Single Subject Credential shall determine, prior to recommending a candidate for the credential, that the candidate meets all legal requirements for the credential, including but not limited to:

- Possession of a baccalaureate or higher degree other than in professional education from a regionally accredited institution
- Completion of Basic Skills Requirement
- Completion of an accredited professional preparation program
- Completion of the subject matter requirement
- Demonstration of knowledge of the principles and provisions of the Constitution of the United States
- Passage of the Teaching Performance Assessment
- Passage of the Reading Instruction Competence Assessment (RICA) (for Multiple Subject Candidates). Reference: Education Code Sections 44259 (b) and 44283 (b) (8)

### **Response**

Candidates in the Multiple Subject and Single Subject credential program can access program completion requirements in the TCP handbook. Upon completion of the program requirements, candidates are required to submit an online request. Submission of the application and all required documentation initiates an evaluation and credential recommendation for the credential issuance with the CTC. Students are advised when enrolled in ED 551 Seminar in Directed Elementary Education/ ED 552 Seminar in Directed Secondary Education with details of how and when to apply for the preliminary credential.
